Water Hydrant Use:

Use of Portable Meter	\$250.00 for 2 week period \$100.00 per each additional week period
Fee for Water Usage	2x the current water rate as set by the Village Board of Trustees

Miscellaneous:

1. When the required escrow deposit amount falls below 30% of the initial deposit, the applicant shall replenish the deposited amount to the full initial value prior to any further review of the application
2. The Planning Board, Zoning Board of appeals and Village Board of Trustees may, in their discretion, waive a portion of the escrow deposit for applications that do not involve any construction
3. Informal discussion before any board (i.e. request for workshop session) will be \$200.00
4. The Village reserves the right to require bonding or other surety to ensure that offsite or onsite improvements are constructed and maintained in accordance with approved plans.
5. The cost of public notice shall be paid for by the applicant.
