2021 TENTATIVE ASSESSMENT ROLL And HEARING OF COMPLAINTS

PLEASE TAKE NOTICE that the 2021 Tentative Assessment Roll has been filed in the Office of the Village Clerk-Treasurer, located at 31 Mountain Avenue, Hillburn, New York. Due to the COVID-19 pandemic, several procedures applicable to the grievance process have been modified. The Board of Trustees and the Assessor will meet virtually for the purpose of completing such assessment roll and hearing and determining grievances in relation thereto on Tuesday, February 16, 2021, between the hours of 5:00 p.m. to 9:00 p.m., via GoToMeeting. The GoToMeeting address can be obtained by calling the Village Clerk's office or on the Village website, Hillburn.org. Grievance application forms are available at the Office of the Clerk-Treasurer and the grievance application forms must be filed on or before February 16, 2021.

Grievances can be filed from Monday, February 1st 2021 through Grievance Day, Tuesday February 16, 2021 at 9:00pm.

You do not need to make an appointment to just listen in to the meeting. We welcome public attendance via GotoMeeting.

The Village Office is open Monday through Friday, from 9:00am to 4:30pm and on Grievance Day, from 9:00am through 9:00pm. Please note that all grievances must be filed at Village of Hillburn Municipal building on or before 9:00pm on February 16, 2021.

During the teleconference, the Chairman of the Board will call you. You will identify yourself when called and be given the ability to speak. You must follow the sworn affidavit below. After your sworn statement of affirmation, please wait for the Chairman's instructions.
