<u>Police Commissioner's Report</u> – Deferred until the arrival of a Ramapo Police Officer.

### <u>Presentation by Geoff Welsh – RE: Pilgrim Pipelines</u>

A map of the Ramapo Watershed was displayed illustrating the route of the proposed pipelines. Mr. Welsh addressed the Village Board and the public and provided the following information:

- Pilgrim Pipeline Holdings, LLC is a private industry that is proposing to construct two parallel pipelines to run from Albany to Linden, NJ. One pipeline would carry crude oil south to refineries or international distribution hubs, and the other would carry refined petroleum products north.
- A small portion of the proposed pipeline would run through the Village of Hillburn.
- Ramapo is the water supply most at risk for contamination in the event of a spill.
- The proposed pipeline will not decrease the current train shipments, as the oil is slated for export.
- Underground spills are more dangerous than aboveground spills.

Mr. Welsh stated that a 1909 law gives credence to resolutions adopted villages and cities opposing the pipeline. Of the 9 affected villages, 7 have adopted resolutions, 1 is in the process, and Hillburn would be the last. A model Resolution could be provided by the River Keepers. Attorney Cassidy stated she will review any proposed Resolution.

Village resident, Rich Morales, stated that since 2010, over 7 million gallons of fuel have been spilled in the United States, causing approximately \$2.8 billion in damages.

Information sheets and a Petition opposing the pipelines were available for residents' signatures.

Mayor Flanagan thanked Mr. Welsh for his presentation.

#### **Community Development Program**

Trustee DeGraw reported she and Deputy Clerk Yvonne Van Dunk had attended the 2017 CDBG Application Training meeting on 11/3/16 and determined that, in accordance with the revised income threshold, the Village of Hillburn does not qualify for funding.

At the Citizens Advisory Committee Meeting held at 6:00PM this evening, a discussion was held regarding opting out of the Consortium for the 2017 CD Block Grant Funds.

The following RESOLUTION was offered by Trustee DeGraw and seconded by Trustee O'Blenis who moved its adoption:

**WHEREAS**, it was confirmed at the 11/3/16 Community Development Block Grant, HOME and ESG Application Training Session that the Village of Hillburn is not eligible, in accordance with the "42.52% eligible as Area Benefit"; and

**WHEREAS**, previous actual CDBG Awards to the Village of Hillburn were subsequently cancelled/"recaptured" by the RC Office of Community Development:

• 2012-13 \$10,000 (Sidewalk Project)

• 2014 \$48,000 (Youth Center Heating/Cooling Unit)

• 2015 \$25,000 (After School Program)

**THEREFORE, BE IT RESOLVED** that the Village of Hillburn will not be a part of the Consortium of Rockland County Towns and Villages "Urban County" for the 2017 Community Development Block Grant Funds under the U.S. Housing & Community Development Acts and its amendments; and a 2017 CDBG, HOME and ESG Application will not be filed by the Village of Hillburn.
