Hillburn Clean-Up Date/Keep Rockland Beautiful - 4/24/2021 - Supt. Conklin reported there was a good turnout of adults and youth. Over 60 bags of garbage and 40-50 tires were collected. A thank you letter will be sent to Steven Monahan for his assistance in providing McDonald's vouchers that were distributed to volunteers.

<u>Veterans Park Pond</u> – 4/13/2021 Quote from Princeton Hydro for 2021 Pond Treatment Services.

-Engineer Mancuso stated she would like to speak to a representative of Princeton Hydro to determine if there is a method to remove dead vegetation, rather than dredging. (Supt. Conklin will notify her of the scheduled date for treatment)

Purchase of Flags (Telephone Poles along Memorial Day Parade Route) - A quote for new flags and aluminum poles will be obtained from Gates Flag & Banner by the next Board meeting. Costco also sells the flags and poles for \$30.00 each. <u>Village Municipal Building</u> – 3/29/2021 Proposal - On-Time Contracting – Gutters/Soffits, etc.: \$7,500.00. Tabled at 4/13/2021 meeting. Supt. Conklin stated he is obtaining a second quote.

Purchase of Fuel from the Village of Suffern —The Village Clerk-Treasurer spoke with Suffern Treasurer Michael Genito to clarify billing procedures. During the conversation, Mr. Genito provided information regarding the Wex Fuel Card Program that the Village of Hillburn may want to consider. The Village Board approved further research.

SAM Capital Funding Grant Application – Funding Application: Purchase of *Scott Air Packs and Back Hoe – (*Scott Air Packs purchased with alternate funding. Item on Application to be revised) – The Clerk-Treasurer received a response from the representative at the Ways and Means Committee, who advised that an updated application is needed. DPW Supt. Conklin will contact HO Penn for an updated quote for the backhoe, and Engineer Mancuso will prepare and supply an estimated cost for the Pre-Fab Building (replaces the Scott Air Packs).

LED Street Lighting Upgrade

O & R – RE: NY Public Service Commission Case 16-E-0226, O & R's Add'l LED Street Lighting Options Available to Municipalities – Competitive alternatives being offered by O & R regarding LED lighting – no further report.

-Annual Upgrade - Locations for the (4) free LED upgrades: area of 33 Terrace Ave., corner of Suffern Rd & Lake Ave., corner of Lake Ave. & Fifth St., and on Mountain Ave. To date, approx. 50% of streetlights have been upgraded to LED.

<u>Village Engineer's Report</u> – Engineer Mancuso reported:

<u>4th St. Thruway Bridge Curbing</u> – A Request for Quotes has been prepared by Village Engineer Mancuso and supplied to potential contractor(s).

-A discussion was held on whether repair/replacement of the curbing is the responsibility of the Village, or the NYS Thruway. Village Engineer will reach out to a representative of the NYS Thruway to confirm.

<u>2021 Repavement Project</u> – Proposed Areas: 5th St (from Mountain Ave. to Hickory Ave.), Hickory Avenue (from 5th St. to 6th St.), 6th St. (from Hickory Ave. to Rockland Ave.)

-Engineer Mancuso reported she is in contact with Tilcon New York and All County Paving for proposals for paving, and she will reach out to Cavaliere Industries for proposals for milling.

<u>Village Attorney's Report</u> – Attorney Rice reported:

<u>4/15/2021 NYCOM Webinar – RE: New York's Marijuana Regulation and Taxation Act (MRTA): The Legalization of Adult-Use Cannabis in New York</u> – Attorney Rice gave an overview of the new legislation.

- Although the MRTA legalizes possession and use of cannabis immediately, the actual sale of adult-use cannabis is not expected to go into effect until late 2022 or early 2023.
- Municipalities can opt out of hosting retail cannabis dispensaries and/or on-site cannabis consumption establishments within its boundaries by adopting a Local Law that is subject to permissive referendum.
- The Local Law must be adopted on or before 12/31/2021.
- Depending on the adoption date of the Local Law, a Special Election may need to be held if a Petition is filed.

-It was the consensus of the Village Board that no action be taken at this time.

<u>Proposed Agreement with MuniciPay (Online Bill Pay Program)</u> – Attorney Rice stated he had reviewed the Agreement and has no legal objections. Prior to executing the Agreement with MuniciPay, review of other companies will be made.

<u>User Fees</u> –Attorney Rice reported he is reviewing the user fees of other Villages.

-Mayor Tursi reported on a recent phone call received at the Village Office regarding filming in the Village. A discussion was held regarding implementing an Application Form and requirements such as fees/insurance.

<u>Emergency Preparedness Plan</u> – Copies of the Plan, adopted on 3/31/2021, have been provided to the Village Board, DPW Supt., HFD Chief and the Village Attorney.

Personnel Manual – Manual is to be updated to include COVID-19 protocol.

ADOPTION OF BUDGET (Public Hearing held 4/13/2021)

Mayor Tursi reported that the Appropriated Cash Surplus reflected on the Tentative Budget presented at the 4/13/2021 Public Hearing was increased from \$100,000.00 to \$125,000.00, thus decreasing the 2021 Tax Rate from \$4.70 per \$100 valuation to \$4.60 per \$100 valuation.

A MOTION was made by Trustee Tarantino and seconded by Trustee O'Blenis to ADOPT the 2021-2022 Tentative General Fund Budget, with the amended tax rate of \$4.60/100 valuation, and to ADOPT the 2021-2022 Tentative Water Fund Budget.
