RESOLUTION - Election to Use Standard Allowance for ARPA21 Funds

WHEREAS, On January 6, 2022, the U.S. Department of the Treasurer adopted a final rule ("Final Rule" on implementing the receipt and use of Coronavirus State and Local Fiscal Recovery Funds ("ARPA21 Funds") for Non-Entitlement Units, including the Village of Hillburn; and

WHEREAS, the Final Rule permits recipients to determine the amount of revenue lost due to the COVID-19 pandemic ("Pandemic") either according to a formula, or by claiming a standard allowance of up to \$10 million, not to exceed their total award allocation ("Standard Allowance"); and

WHEREAS, a recipient that plans to use the Standard Allowance must make a one-time election and report it to Treasury through regular programmatic reporting.

NOW, THEREFORE BE IT RESOLVED that the Village of Hillburn Board of Trustees hereby makes a onetime election to use the Standard Allowance in lieu of determining the amount of revenue lost due to the Pandemic.

Mayoral Address was delivered by the Honorable Mayor Joseph P. Tursi

"I would like to begin by welcoming Trustee David McNally to the village board. As you may know, Dave is a teacher for Suffern Central School district where he also serves as a coach for lacrosse, football and various other sports. Dave and his wife Ann have lived in the village since, I believe, 1986 and they raised their four children here. Dave also served for many years on the zoning board of appeals, most recently in the capacity of chairperson. I believe that Dave's knowledge and commitment to the village will be an asset to the entire community. On behalf of the village board and staff, I would like to say congratulations and we look forward to working with you.

I would also like to congratulate Village Justice Jerry Jefferson on being re-elected to another fouryear term. If you aren't aware, the Judge is a huge baseball fan. Sadly though, he's a Red Sox fan. That being said, he is a good man and I believe that he has the village's best interests at heart when he is on the bench. Congratulations, Your Honor.

Also, on behalf of the board and staff, I would like to thank Bonni O'Blenis for her many years of service to the village as trustee. Bonni has served alongside three mayors. A lifelong village resident with a large family I am sure that she is ready to start enjoying retirement. Best of luck Bonni.

I would like to bring you up to date about some of the issues that we are working on here in the village.

With the assistance of State Senator Reichlin-Melnick, the village is very close to receiving a \$75,000 grant to be used for improvements to the Veterans Memorial Park pond. These funds will require an equal match of funds by the village. The initial disbursement of these funds will be used for engineering and design of the pond. As the centerpiece of the village, we believe that it is necessary to begin this project and restore the pond to a natural habitat that will be enjoyed by not only future generations of residents, but wildlife as well.

The past three years utilizing Consolidated Local Street and Highway Improvement Program funds provided by the state, the village did some long overdue paving projects. This year we intend to apply that funding towards sidewalk repairs around the village. Without these funds, it would be nearly impossible for the village to take on these projects.

In an effort to be more environmentally friendly, and to cut down on utility bills for the village, we are looking at a project to convert the lighting in village buildings to LED. The initial phase of the project will be for the replacement of the fixtures in the firehouse and here, in the community room. The next phase will be village hall. This project will save the village approximately 40 percent savings in electric usage. We will apply for state reimbursement programs to offset the cost of this project. I believe that it would also be prudent for the village board to seek proposals and grants to take the village off of the electric grid by going solar in the near future.

After months of design, we will be launching our newly updated website this week. The village contracted with Equitek of Rochester NY to design and host the webpage.

On September 18 of 2020, the village lost one of its most community minded citizens, Judy Starr. Judy was a 46-year member of the Hillburn Ladies Auxiliary. She served as president of the auxiliary for 25 years. She pursued the annual Christmas caroling event, originally organized by Rita Mariano, that visited, sang carols and gave gifts to our homebound seniors.

She was also a member of the Hillburn Seniors Organization where she served as President from January 2013 until December 2016.

In 2012, she was named as Hillburn Citizen of the Year.

Judy was predeceased by her husband Ed. She is survived by her children Michael, Jaime, Brandi and Shane and of course grandchildren.

So this evening in recognition of Judy's unwavering commitment to the Hillburn Community, I would like to ask for a motion by the Village Board to dedicate this very room to Judy and that it will now be known as the Judy L. Starr Community Center.

The following RESOLUTION was offered by Trustee Tarantino and seconded by Trustee McNally who moved its adoption:

WHEREAS, it is the desire of the Hillburn Village Board of Trustees to recognize Judy L. Starr for her many years of sincere dedication and devoted service to the Village of Hillburn as a volunteer member and President of the Hillburn Ladies Auxiliary and Hillburn Senior Citizens; and

WHEREAS, Judy L. Starr spent many hours in the Hillburn Community Center for activities associated with her duties in the Hillburn Ladies Auxiliary and the Hillburn Senior Citizens;

NOW, THEREFORE, BE IT RESOLVED, that the Hillburn Community Center is hereby dedicated to Judy L. Starr; and

FURTHER, this dedication is hereby memorialized with a sign renaming the room as the "Judy L. Starr Community Center".

Chief Shane Starr who has served the past six years as chief will be stepping down this month. I would like to thank you, personally Chief, for leading the department and it was a pleasure working with you.
