Mayor Tursi reviewed the 2022-2023 Tentative General Fund Budget, pointing out changes from last year's budget. Tentative 2022-2023 Tax Rate: \$4.83/\$100 valuation (2021-2022 Tax Rate: 4.60/\$100 valuation). Factors attributed to the need for the increase include decreases in revenues and minimal increase to assessed valuations.

DPW Report - DPW Supt. Conklin

Repair of Roadways and Storm Drains

- -The NYS DOT will be in the Village tomorrow morning to grind down a section of 4th St. so that it can be patched. This work is being performed under the Shared Services Agreement between the NYS DOT and the Village of Hillburn.
- -The DPW has patched potholes on the west side of the Village.
- -Storm drains are being repaired.
- -The HFD Chief's car has been towed to Suffern Auto Sales & Service (unable to gain velocity). Due to a decline in quality of service, the truck may be transferred to Complete Auto Works, or to a Ford Dealership. Approved by Village Board.

-2016 DPW Truck -The truck has developed a "death wobble" (uncontrollable shaking, specifically in the steering wheel). The truck was still wobbling after two tie rod ends were installed by Suffern Auto Sales & Service (invoice is forthcoming). Supt. Conklin stated he had then installed a steering damper which took away a lot of the wobble. Due to the tie rods were bad, it wore down the tires. He recommends two new tires be purchased from Eastern State Tires at the cost of \$195.50 per tire, plus \$50.00 for mount/balance. Alignment will also be necessary, and he recommends taking the truck to Garnerville Wheel Alignment (only place that can do heavy trucks). Approved by Village Board.
