RESOLUTION EXPRESSING THE INTENT OF THE BOARD OF TRUSTEES TO OBTAIN A ANTICIPATION NOTE IN THE APPROXIMATE AMOUNT OF \$35,000 TO FINANCE A PORTION OF THE CONSTRUCTION OF A DPW PREFABRICATED GARAGE

BE IT ENACTED by the Board of Trustees of the Village of Hillburn as follows:

WHEREAS, the DPW Garage located at 40 5th Street in the Village of Hillburn was declared to be unsafe and demolished in 2015; and

WHEREAS, a grant has been made available to the Village through the DASNY; and

WHEREAS, the anticipated cost to construct a replace prefabricated DPW Garage is approximately \$84,500; and

WHEREAS, the funds to be obtained from the DASNY grant is \$49,500.00; and

WHEREAS, additional funding is required in the approximate amount of \$35,000; and

WHEREAS, the Board of Trustees intends to finance the additional \$35,000 necessary to complete the project by obtaining a Bond Anticipation Note.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Village of Hillburn that the Board of Trustees declares it intend to obtain a Bond Anticipation Note in the amount of \$35,000 or such additional amount as may be required to finance its portion of the construction cost of the DPW Garage over and above the funds to be provided by the DASNY grant; and

BE IT RESOLVED, that the Village Clerk-Treasurer is authorized to contact bond counsel to obtain the necessary paperwork and resolutions for such bond anticipation note at the appropriate time as directed by the Mayor.
