SAM Capital Funding Grant Applications

-<u>SAM Grant #24626 - Sponsored by Assemblyman Lawler's Office</u> – Revised Funding Application: Pre-Fab Building and Back Hoe – Submitted.

The following RESOLUTION was offered by Trustee O'Blenis and seconded by Trustee Tarantino who moved its adoption:

WHEREAS, the Village of Hillburn has been nominated for a State and Municipal Capital Grant (SAM) through the office of NYS Assemblyman Mike Lawler, in the amount of \$125,000.00; and

WHEREAS, the Village of Hillburn's project for this grant will be "Purchase of Backhoe and Construction of Pre-Fab Building"; and

WHEREAS, the amount of funding being requested through the SAM Grant is \$125,000.00 and the estimated cost of project is \$191,510.00; and

THEREFORE, BE IT RESOLVED, that the Village of Hillburn is committed to funding the project costs not covered by the Grant, in the amount of \$66, 510.00, as follows:

-SAM Grant #24595 - Sponsored by Senator Elijah Reichlin-Melnick's Office - 6/30/2021 Letter Request for Funding -Proposed Project Application: Veterans Memorial Park Pond Restoration - The Senator has given final legislative sign off and DASNY will begin the DGA process shortly.

-Engineer Mancuso reported that it was determined by DASNY that the budget item of "muck remover", in the amount of \$1,000 is a maintenance cost and, therefore, not reimbursable.

<u>Village Engineer's Report</u> – Engineer Mancuso reported:

-Quotes for Pre-Fab Building – Quote received last year from Steel Master has increased by 30%. Engineer Mancuso stated she has solicited for a stick-built structure and is waiting for quotes from two contractors (structure only). Demolition of foundation will be done by the DPW, new foundation possibly by Salomone. A quote from an electrical contractor will be needed for lighting and heating.

Sixth St. Culvert (area of Boulder Ave) – Preliminary Cost Estimate provided by Brooker Engineering: \$471,315.00. -Application filed with FEMA on 11/19/2021 - Response pending.

DR-4480 COVID-19 Pandemic Hazard Mitigation Grant Program (HMGP) - Federal Funding Available. The 6th Street Culvert may qualify.

2021 Repavement Project - Funding: CHIPs Program - Project Areas: 5th St (from Mountain Ave. to Hickory Ave.), Hickory Avenue (from 5th St. to 6th St.), 6th St. (from Hickory Ave. to Rockland Ave.)

-A request was filed with NYS DOT on 1/20/2022 for reimbursement of \$56,435.57 (Total Project Cost) through CHIPS. In response to notification received from NYS DOT today, 1/25/2022, a revised application will be filed for reimbursement in the amount of \$34,342.74 through CHIPS and the balance, in the amount of \$22,092.83 will be requested through PAVE NY.
