INTRODUCTORY LOCAL LAW NO. 6 OF 2025

**A LOCAL LAW AMENDING THE CODE OF THE VILLAGE
OF HILLBURN BY ADDING A NEW CHAPTER, CHAPTER 7,
“CODE ENFORCEMENT”**

BE IT ENACTED by the Board of Trustees of the Village of Hillburn, as follows:

Section 1. The Code of the Village of Hillburn is hereby amended to add a new chapter, Chapter 7, entitled “Code Enforcement” to provide as follows:

§ 7-1 Code Enforcement Officer(s).

The Board of Trustees may appoint one or more Code Enforcement Officer(s) to enforce the provisions of various chapters of the Code of the Village of Hillburn and to appear in courts of competent jurisdiction in order to enforce the same.

§ 7-2 Chapters Enforced by Building Inspector and Code Enforcement Officer(s).

In addition to any other chapters or provisions which the Building Inspector and/or Code Enforcement Officer may heretofore have been authorized to enforce, notwithstanding anything to the contrary in the Code of the Village of Hillburn, the Building Inspector and Code Enforcement Officer(s) are hereby authorized to enforce the provisions of:

- A. Chapter 50, Alarm Systems.
- B. Chapter 54, Alcoholic Beverages.
- C. Chapter 60, Amusement Devices.
- D. Chapter 65, Animals.
- E. Chapter 70, Auctioneers.
- F. Chapter 80, Building Construction and Fire Prevention.
- G. Chapter 84, Building Demolition.
- H. Chapter 88, Buildings and Structures, Unsafe.
- I. Chapter 92, Buildings, Numbering of.
- J. Chapter 114, Explosives.
- K. Chapter 122, Filming.

§ 7-3 Appearance Tickets.

The Code Enforcement Officer(s) is hereby authorized to issue appearance tickets in the name of the Village of Hillburn for violation of any chapter, section and/or provision of the Code of the Village of Hillburn for which he is authorized to enforce.

Section 2. This local law shall take effect immediately upon filing with the Secretary of State.
