Auditor's Report – FYE 5/31/22 – Berard & Associates CPA's P.C.

Donalee Berard presented a summary of the FYE 5/31/22 audit to the Village Board outlining key points of the audit.

Ms. Berard narrated the report:

- New this year, LOSAP was added to the general fund.
- The Statements of Revenues and Expenditures reflect positive balances.
- -The Village of Hillburn is in sound financial shape, in accordance with the Y/E 5/31/22 Audit.
- The Water Fund has improved. The repairs' effectiveness helped reduce the loss of water, and the fund is being considered profitable.
- -Ms. Berard thanked the Village staff for all their help.
- -The Village Board thanked Ms. Berard and the staff from Berard & Assoc. for the preparation and presentation of the Audit for FYE 5/31/2022.

Police Commissioner's Report –

- Mayor Tursi reported on the ongoing investigation from the Ramapo Police Dept. pertaining to gunshots fired within the Village. Apprehension is unknown – the investigation is still ongoing.

-Emergency Resurfacing Upper End of Sixth Street Road to the Tank- The overlay for a 2-inch cap, 800 feet long and 1500 feet wide, road repair is necessary. Asst. Clerk-Treasurer questioned if this project would be near the 6th St. culvert. Supt. Conklin replied that the work is above it.

With the construction materials prices rising and winter weather approaching, Supt. Conklin advised it is urgent to get it repaired. Two proposals were received: Tilcon: \$ 29,710.40 D&R Paving, LLC: \$26,400.00

Trustee Tarantino asked if three bids are required. Supt. Conklin stated that Tilcon participates with the Town's Shared services and that D&R Paving, LLC was very responsive. Supt. Conklin requested the third quote from another company, but they have not responded.

Village Attorney Rice stated that three proposals were requested. Even though only two responded and since it is under the bid requirements, the Village Board can move forward with the project. Mayor Tursi stated that if the Board does not act soon, the road could get worse making it unsafe for drivers.

Asst. Clerk-Treasurer asked, how the job would be funded. RE: 2022 CHIPS Program- Approximately \$15,000.00 will be available after the 2022 Curb & Sidewalk Improvements and Engineer services.

- <u>Allied Drilling, Inc.</u> They were authorized to proceed, and have an executed contract. They obtained the Health Permit that was required. Allied Drilling, Inc. could begin as soon as next week. No firm date is scheduled.

On 10/26/22, a pre-construction meeting is scheduled, at the DPW garage, since Eve Mancuso is schedule to be on vacation Friday – Tuesday.

If they provide all necessary documents by Friday, 10/28. They may start Monday, 10/31.

-Gregory Imam from Orange & Rockland – reached out to Eve Mancuso. They want to reinforce the riprap up along the main towers that is around the pump. These towers provide power in the village. This is maintenance of an existing tower for more storm resistance.

Eve Mancuso questioned what would the Village Board need from them. She stated that Sloatsburg had the same job performed. She was asked to look at the plans and keep an eye on the project.

It is not within the Village jurisdiction as it is a utility maintenance. Eve Mancuso will supply the pole numbers that would be encompassed. Mayor Tursi requested that if they could keep the truck's traffic out of the Village. Eve Mancuso will check all access staging that would impact the Village.

-<u>Pre-Fab Building</u> – Water in not needed, just electricity and since steel is very expensive, masonry blocking would make it easier to build with a shingled roof. Heating would be infrared. Slabs, and demolishing would be involved. Eve Mancuso will continue to explore options. Limited contractors are involved with steel building.

-<u>Draft of Local Law for Amendment of Zoning Law & Comprehensive Plan</u> – Attorney Rice reported that at the last meeting, the Board authorized the revision to go to the Rockland County Planning Department. The GML report is pending, and once received, a Public Hearing can be set.

-<u>Dwaine C. Perry vs. Village of Hillburn et al</u> – <u>Notice of Claim (Undated)</u> <u>Received 10/11/2022</u> – Notice of Claim was received and referred to the insurance carrier. They appointed counsel to conduct the 50-h, which is the disposition that a municipality is entitled to take after a notice of claim has been filed and before an action can be commence. Secondly, his attorney wrote a letter asking for accommodation under the Americans with Disabilities Act. Attorney Rice drafted a letter responding that disability has not been proven or any prior accommodations requested. As discussed with the Mayor, Mr. Perry is allowed to park on the street unless there is a snowstorm.
